Favorite Place: Any ocean beach (Kailua, Phuket, Eilat, Cabo, to name a few favorites)

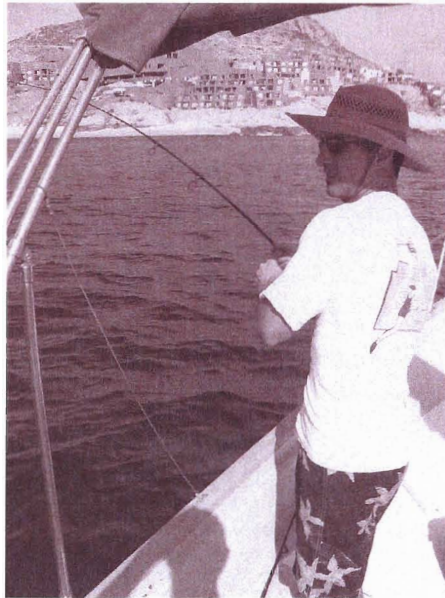
If you could do it all over again, I would . . . Invent a time machine to relive my high school years (without the mullet)
